The discussion, which shall be conducted in closed session, shall be disclosed upon termination of litigation or contractual matter, upon resolution of the personnel matter with consent of said person or persons and as provided by N.J.S.A. 4-12 but in no case later than two (2) years from this date. These minutes shall be available as soon as the matter is resolved or not later than two years hence. Borough Attorney, Greg Mascera responds that the Executive Session will be discussion contract matters in regards to PBA contract in regards to health benefits current and retirees and the Sewer Director Contract, and the Health Insurance provider Fairview Associates and Personnel matters regarding the Borough Administrator and the Water Director. On a motion made by Councilman Slattery, and seconded by Councilman Norton, unanimously affirmed, the Council moved into Executive Session at 10:30 P.M.
