ADDITIONAL RECYCLABLES:

Appliances and Metal Items: Refrigerators, freezers, washers, dryers, furnaces, stoves, water heaters, air conditioners, metal bedsteads, swing sets, shelving, cabinets, desks and major auto parts require recycling stickers. Please purchase and affix them to items prior to setting out for collection. Items without stickers will not be collected.

Appliances that contain chemical refrigerant (air conditioners, freezers, refrigerators) require three stickers for each item at a total cost of \$15 per item.

Auto Truck Tires: Automobile and light truck tires, without rims, are collected. One sticker is needed for each pair.

Corrugated Cardboard: Contact Public Works Dept. at 403-4640 for information and assistance.

Clothing: Contact Goodwill Industries at (973) 621-9560 (X12) or American Rescue Workers at (973) 589-5772. Both organizations will collect from your home.

No electronic waste can go into garbage. Please recycle.

RECYCLING STICKERS may be purchased at Borough Hall, Mon. – Fri. 8:30 A.M. – 4:30 P.M. or by mailing a stamped, self-addressed envelope with check or money order in amount of \$5 per item or \$15 for each refrigerant item to RECYCLING PROGRAM, BOROUGH OF CALDWELL, 1 PROVOST SQ., CALDWELL, NJ 07006. Recycling stickers & receipt will be mailed to you. When you receive the stickers, please call Public Works Dept. at 403-4640 at least 48 hours in advance to arrange for collection.

MONDAY CURBSIDE COLLECTION

Caldwell contracts with The First Occupational Center for collection of paper products and commingled materials on alternate weeks. There is NO collection on major holidays, but recycling is collected the following day (Tuesday).

All materials must be placed at curbside the night before or by 6 A.M. on collection day. Materials not properly packaged or not scheduled for pickup that day **WILL BE LEFT AT THE CURB**. If material for pickup remains at curbside Tuesday morning, please call the

NEWSPAPER & MIXED PAPER:

Please note: The following items **MUST be placed in two separated containers and are not to be mixed.**

NEWSPAPERS & THEIR INSERTS

- must be tied in bundles with string or,
- stacked in a rigid, reusable container, and
- Bundles/containers are not to exceed 30 lbs.

***NEWSPAPERS MAY NOT BE PLACED IN BROWN PAPER BAGS OR PLASTIC BAGS**

MIXED PAPER, such as junk mail, magazines, catalogues, school and computer paper

- must be tied in bundles with string, or
- stacked in a rigid, reusable container, and
- sat out beside the newspaper bundle/container,

***MIXED PAPER MAY NOT BE PLACED IN BROWN PAPER BAGS OR PLASTIC BAGS**

COMMINGLED MATERIALS:

Glass, aluminum, tin & steel food & beverage containers, plastic soda, milk and detergent bottles marked PETE #1 & HDPE #2, clean aluminum foil and pie tins are all recyclable materials.

Rinse and place in rigid, reusable containers not exceeding 30 lbs. These items **MAY NOT** be placed in brown paper or plastic bags.

BULK COLLECTION REMINDER

Bulk items, other than recyclables, such as tables, chairs, sofas, rugs, etc. are permitted to be placed at the curb on regular collection days the weeks of

July 7th, Sept. 22nd, January 5th, and April 6th

LEAF BAGS

Residents may purchase biodegradable leaf bags at the Caldwell Borough Hall, One Provost Square, Caldwell, NJ Monday through Friday, 8:30 A.M. to 4:30 P.M. Single bags are 30 cents each or \$3.00 for a bundle of 10 bags.

Leaf bags are available at Caldwell Community Center nights and weekends.

Call Before You Cut! (a tree)

The Borough of Caldwell has a "Tree Removal and Protection Ordinance" in place. The town considers that both ornamental and full sized trees are inherently valuable as community assets, and has adopted this ordinance (227) to protect them. Knowing that circumstances can arise where tree removal is necessary, the Borough has established a process which may permit the cutting down of trees.

- If a property owner needs to remove a healthy tree that would otherwise be protected (ornamental trees with a diameter of 3 inches or greater at 4 feet above the ground, or evergreen trees with a diameter of 6 inches or greater at 4 1/2 feet above the ground), an application process has been included in the ordinance.
- If the application to remove a healthy tree is approved, the property owner may cut down the tree (or trees) in question. However, the ordinance requires that a reasonable replacement be planted on the property, if possible. If not, a replacement can be planted elsewhere in Caldwell.
- If the tree in question is dead, diseased, or poses a safety hazard, they may be removed without being replaced. An application for removal is still required and a permit issued to take down the tree.
- Street trees are property of the Borough of Caldwell and not to be removed. Contact the Caldwell Tree Committee with concerns/questions about street trees.
- An application for tree removal is required by the Borough of Caldwell. To avoid a fine of up to \$1,000 per tree, file an application for tree removal with the Borough.
